Hearing Protection in Agriculture

One of the most common hazards in U.S. workplaces is noise. The National Institute for Occupational Safety and Health (NIOSH) estimates that 30 million workers in the U.S. are exposed to levels of noise that may not be safe. According to OSHA, "exposure to high levels of noise may cause hearing loss, create physical and psychological stress, reduce productivity, interfere with communication, and contribute to accidents and injuries by making it difficult to hear warning signals." Short term exposure can lead to a ringing in your ears or a temporary change in hearing.

However, prolonged or repeated exposure causes permanent hearing loss.

On the farm, machines can get very loud. A tractor without a cab can reach 100 decibels, and chain saws can reach 110 decibels, which is about the same noise level as a rock concert. Scientists recommend that you use hearing protection when you are in places where the noise level is at or above 85 decibels. Very loud noises, even if they last for only a short time, can cause immediate hearing damage. OSHA requires employers to determine if workers are exposed to excessive noise in the workplace. If so, the employers must implement feasible engineering or administrative controls to eliminate or reduce hazardous levels of noise. Where controls are not sufficient, employers must implement an effective hearing conservation program.

What Can AgrAbility Do For You?

When California AgrAbility visits farms and work sites of farmers



and farm workers, our staff often recognizes that workers are not wearing hearing protection. We recommend that workers should always wear hearing protection because although a worker may be in a quiet environment, sudden or loud noises are always a potential danger.

California AgrAbility assists farmworkers to obtain fitted hearing aids to help them to work safely.

I have impaired hearing, but I do not know how to get a hearing aid, what can I do?

There are many options because there are many vendors. First, you will have to get a hearing test. There are hearing tests that you can take online, however we recommend that you schedule a visit with a licensed professional to ensure you receive an accurate reading.
